Q: Who's a historical woman that you admire?

A: I thought about this quite hard, and on the basis that you've asked who I admire (rather and being inspired by), I would say Emmaline Pankhurst. She believed so strongly in the cause for women to have the vote and she took real steps forward in a world where women were often dismissed as irrelevant; I can't fail to admire her conviction and strength. I know that history is critical of her tactics, and some niggle over her effectiveness because of this, but she stood up for something on behalf of the many while others were able to stay safely at home. I admire anyone who does that, whether it be women's rights, climate change or Black Lives Matter.

Q: What do you love about your job?

A: Well it seems like a rather meagre job after talking about Emmaline Pankhurst, but I what I love is supporting clients to solve problems in their lives. Which basically means I like to make a difference, even if on a smaller scale than some of the other amazing women out there. As an outsourced multifamily office, we take responsibility for many parts of clients' lives that they can't or don't want to look after. But it's more than admin and reporting, it's having strategic conversations about what clients want to achieve (next year, in 10 years) and helping them get there.
